SUBCOMMITTEE REPORTS

Executive Committee

The Executive Committee did not meet.

Medical Standards (David Ben-Eli, MD, Chair)

The following actions items come in the form of seconded motions:

Motion #1: The Protocol Committee recommends the suspension of the requirement for waveform capnography for supraglottic airway placement when there are insufficient resources to provide waveform capnography to all patients requiring advanced airway management. This is not limited to MCI events. This is an emergency protocol change.

A roll-call vote was taken as follows: 19 in favor, 0 opposed, 0 abstain. The motion carried.

Motion #2: To approve revisions to the Hemostatic Dressing Advisory, removing educational material. Use of hemostatic dressings will be at the discretion of the agency medical director. The Training & Education Committee will develop training materials.

A roll-call vote was taken as follows: 19 in favor, 0 opposed, 0 abstain. The motion carried.

REGIONAL COUNCIL UPDATE

The Regional Emergency Medical Services Council of New York City met on March 27, 2018. Dr. Robert Crupi, Chair, gave the following meeting summary:

- 1. There was a moment of silence for Fire Fighter Michael Davidson, who died in a Harlem fire.
- Membership: REMSCO approved the appointment of Marc Kanter, MD, Associate Chief,
 Department of EM at Lincoln Hospital as primary NYC Health & Hospitals representative.
 Alternate member continues to be Dr. Cherisse Berry, Trauma Surgeon, Surgical Intensivist
 at Bellevue Hospital.
- 3. Protocol revisions forwarded from REMAC were affirmed.
- 4. Determinations of Public Need Applications: None
- 5. Transfer of operating Authority applications: None
- 6. A request from Emergency Aid Training to reconsider its previously denied expansion request was referred to the QA Committee.
- 7. A letter will be sent to NYS DOH questioning why several volunteer ambulance services had certificates revoked without hearings as specified in Article 30. This letter will be reviewed by legal counsel prior to submission to NYS DOH.

- 8. Community Paramedicine language will not be in the State budget. There are concerns from nursing and home health aides regarding CP scope of practice. A scope of practice language must be developed and sent to Albany.
- 9. First Net presented information on the A T & T First Responder Communications Initiative.

 The next REMSO meeting will be held on April 24, 2018.

JOINT REMSCO/REMAC QA COMMITTEE UPDATE (MICHAEL REDLENER, MD, CHAIR)

The Joint Regional Emergency Medical Services Council/Regional Emergency Medical Advisory Committee (REMAC) Quality Improvement Committee did not meet. Dr. Michael Redlener, Chair, gave the following update:

Molly Perini,AHA, spoke about First Watch. This is program that may allow hospitals and EMS to improve communications. Grants are available to implement this program and support QA and training.

Drs. Redlener and Schenker gave information on the Stroke Systems of Care initiative. This includes creating a regional protocol for identification and transport of stroke patients, working with NYS DOH to promote the designation of comprehensive stroke centers for treatment of patient with LVO Stroke, and developing training modules for EMS providers. The First Watch ability to improve prehospital/in hospital communications would dovetail into this Stroke initiative.

The next Joint REMSCO/REMAC QA Committee meeting will be held on Wednesday, June 13, 2018.

TRAINING & EDUCATION COMMITTEE UPDATE (Mordechai Lax, EMTP, Chair)

The Training and Education Committee of the Regional EMS Council of New York City met on April 10, 2018. The following is a meeting summary:

1. The BLS IM Epinephrine administration training module has been completed. It will be posted on the REMSCO LMS soon. Training will include using the NYS DOH skill sheet.

- 2. A training module on use of hemostatic dressings is being created. This will include information from the ACS's 'Stop the Bleed' program, and other NAEMT educational products. (REMAC supported using Stop the Bleed materials.)
- A training module on new Stroke information, including updated Stroke Scale will be developed once new protocols are approved by SEMAC. The T&E Committee will work with QA Committee.
- 4. The CLI course has been updated to meet NYS DOH requirements. A draft has b been emailed to Albany, and we are awaiting response. A summer CLI course is anticipated.
- Nominations for Regional Faculty will be submitted to NYS DOH. We are in desperate need of regional faculty and program coordinators. Instructor level courses cannot be conducted without this level of instructors.
- 6. Recommendations regarding EMS Fatigue Studies will be developed into a regional information module
- T&E will work with Stroke TAG in developing and providing standardized training for EMS Providers.

The next meeting of the T&E Committee will be held on Tuesday, June 12, 2018.
