The Joint Regional Emergency Medical Services Council/Regional Emergency Medical Advisory Committee (REMAC) Quality Improvement Committee met on Tuesday, May 14, 2019. The following is a meeting summary:

Patient Care Restrictions

- Two (2) PCR appeals have been received. They are being held pending completion of NYS DOH BEMS investigations.
 - In both cases, the involved EMTs have been fined and reinstated. Committee will lift regional restriction once completed, signed documentation from NYS DOH has been received.

Stroke

- NYC Stroke outcome for April 1 28, 2019 reviewed.
- Creation of an on-line portal for EMS agencies to provide input was discussed

STATE EMS COUNCIL/SEMAC UPDATE (Yedidyah Langsam, PhD)

The State EMS Council (SEMSCO) and State Emergency Medical Advisory Committee (SEMAC) met on May 7 & 8, 2019. The following is a meeting summary:

Staff Report:

- 1. New license platforms being developed:
 - a. Portals for all agencies
 - b. Electronic communications
- 2. EMS Crisis
 - a. Need innovation
 - b. Long distance learning
 - i. Looking for more options
 - ii. Possible increase of 20% to 50% online portion of class

3. Statewide BLS Protocols approved

- a. Mandatory for entire State
- b. DOH will post abbreviated training on line
- c. LMS System being created
- d. Roll out in July

Medical Standards:

- 1. NYC RTF Protocols approved
- 2. ET3 language is present in NYS DOH BLS Protocols.
 - a. NYC does not need approval for the ET3 language it developed.
- 3. Drug Shortages: formulary may be changed as needed by regions based on continuing shortages approved
- 4. Trauma: a full system analysis is being developed.
 - a. Dr. Berry (Bellevue) is working on this self-assessment study to obtain preliminary data.

Education & Training

- 1. CME manual almost completed
- 2. Advise students to schedule their exams on DOH webpage. Do not call DOH.
- 3. Administrative Manuel is in process
- 4. Instructor Policy nearing approval (Actually has been posted on NYS DOH webpage)
- 5. New staff is being hired for Education
- 6. Spinal Motion Restriction videos developed by Laerdal have been updated and include TE recommendations.
- 7. Regional Faculty TAG has been formed. Will meet over summer.

FINANCE

- 1. EMS certification course reimbursement rates will be reviewed.
 - a. DOH staff will provide information on current funding
 - b. Regions must review costs incurred by training centers to conduct EMS certification courses.
 - c. A tool will be designed asking course sponsors to itemize costs associated with courses.
 - i. What costs are shifted to students.

ii. Problems identified:

- Inadequate staffing, inadequate equipment, measure unfunded costs

Dr. Matt Freidman presented a proposed demonstration project for delivering ketamine via specialized nebulizer, "Prehospital Utilization of Nebulized Sub-dissociative Dose Ketamine for managing acute traumatic extremity pain: a prospective observational study. Matt Friedman, MD, will be the Principal Investigator. This is limited to isolated extremity injury.

REMAC discussed this proposed demonstration project:

- Overseen by an IRB
- Informed consent
- Uses an accepted medication via a new route of administration
- Agreed to participate in required REMSCO/REMAC QA

Roll-call and written votes were conducted: 19 in favor, 0 opposed, 1 abstentions. The motion carried.
