The constituents I serve include families living in Brownsville and East New York, neighborhoods which are included in the area which BSVAC proposes to expand. As Chair of the Committee on Social Services, and as a Member of the Committees on Children and Families and Disabilities, respectively, I am deeply involved with trying to help improve the lives of residents in the proposed expansion area.
