#### **EXECUTIVE COMMITTEE REPORT**

Josef Schenker, MD, reported that the Executive Committee met before the REMAC meeting. The following is a summary:

- The Executive Committee formed a Nominations Committee to review officer nominations for REMAC and its subcommittees. The committee recommends the following slate for reappointment:

  - o Bradley Kaufman, MD, REMAC Committee Vice Chairperson
  - o Jeffrey Rabrich, MD, REMAC Committee 2<sup>nd</sup> Vice Chairperson

  - o Pamela Lai, MD, Protocol Committee Chairperson
  - o Paul Barbara, MD, Certification and Credentialing Committee Chairperson
  - o Michael Redlener, MD, Quality Improvement Committee Chairperson

Vice-chair positions are available on the Protocol, Certification and Credentialing, and Quality Improvement committees. Committee members can send all nominations to Marie Diglio. Nominees will be announced at the next REMAC meeting.

- The committee will be reviewing attendance records to determine the status of membership. During the REMAC meeting, Dr. Schenker highlighted the significance of regularly attending committee meetings. Members are required to attend at least four meetings each year. If a member fails to meet this requirement and is still reappointed, the appointing organization must provide a specific reason for the appointment.
- Effective January 2024, New York-Presbyterian Brooklyn Methodist Hospital will discontinue its on-line medical control (OLMC) service. Although the hospital will continue to provide OLMC until all agencies find alternative solutions, this change will present significant challenges for several proprietary and volunteer agencies that depend on the hospital for OLMC. There are five operating On-line Medical Control facilities in the region. However, it is necessary to identify new facilities to compensate for the loss of NY Presbyterian-Methodist's OLMC service. The two potential ideas discussed during the Executive Committee meeting were establishing an internal, regional on-line medical control facility or seeking assistance from an outside agency such as Health + Hospitals. During the REMAC meeting, members raised concerns about transferring the hospital's on-line medical control direction to FDNY, the cost of on-line medical control, and the possibility of charging agencies.

#### SUBCOMMITTEE REPORTS

### Certification & Credentialing Committee (Paul Barbara, MD, Chair)

The Certification & Credentialing Committee met on October 13, 2023. David Ben-Eli, MD, provided the Certification & Credentialing report in the Medical Standards report.

The next Certification & Credentialing Committee meeting is on November 16, 2023, at 10 a.m. via Microsoft Teams.

### Medical Standards (David Ben-Eli, MD, Chair)

David Ben-Eli, MD, reported that Medical Standards met before the REMAC Committee Meeting. The following is a summary:

- Kevin Ward, EMTP, requested a change in the Certification and Credentialing Manual to align with the New York
   State Department of Health. According to the manual, Paramedics must submit their CME package 90 days before
   expiration, but Kevin Ward proposed changing the submission date to 45 days. The committee will provide formal
   clarification language for Medical Standards and REMAC to review.
- David Ben-Eli, MD, reported that protocols are being forwarded to REMAC for voting. Pamela Lai, MD, presented the protocols for review in the Protocol Committee report.

The next Medical Standards Committee meeting is on November 14, 2023, at 3:00 p.m. via Zoom.

#### Protocol Committee (Pamela Lai, MD, Chair)

Pamela Lai, MD, reported that the Protocol Committee met on September 8, 2023. The following is a summary:

 Medical Standards brought forward a seconded motion to REMAC to accept revisions to the "General Pain Management (Adult and Pediatric)" protocol. The proposed changes clarify the titration of Morphine and Fentanyl.

Marie Diglio conducted a roll call vote, and the results were 20 Approved, 0 Opposed, and 1 Abstention. The motion carried.

Medical Standards brought forward a seconded motion to REMAC to accept revisions to "Appendix B: Universal
Approach to the EMS Call" in the Appendix. The proposed change eliminates "elevate legs as needed" during
circulation management of the primary patient assessment.

Marie Diglio conducted a roll call vote, and the results were 20 Approved, 0 Opposed, and 0 Abstentions. The motion carried.

• Medical Standards brought forward a seconded motion to REMAC to accept revisions to the "Alternative Treatment/Alternative Transport Destination Decisions" in the General Operating Procedures. The proposed changes state:

The patient must be offered either treat-in-place with patient release or transport to an alternate destination if that patient meets the criteria in Appendix P: Alternate Destination/Treat-in-Place Patient Selection Criteria. If the patient refuses despite appropriate explanations, then the patient may be offered transport to the nearest 911 System Ambulance Destination Emergency Department (Appendix I), unless the patient has any of the following conditions...

Marie Diglio conducted a roll call vote, and the results were 20 Approved, 0 Opposed, and 0 Abstentions. The motion carried.

Medical Standards brought forward a seconded motion REMAC to accept revisions to "Appendix P: Alternate
 Destination/Treat-in-Place Patient Selection Criteria" in Appendix P. The proposed changes are the inclusion and
 exclusion criteria for alternate destination and treat-in-place patient selection criteria. Medical Standards
 approved these changes on June 6, 2023.

Marie Diglio conducted a roll call vote, and the results were 19 Approved, 0 Opposed, and 1 Abstention. The motion carried.

- Medical Standards brought forward a seconded motion to REMAC to accept revisions to the "Severe Bradycardia (Pediatric)" protocol. The proposed changes in the "CFR and All Provider Levels" section are the following:
  - Check for a pulse every two (2) minutes and perform the following:
    - Heart rate ≥ 60 beats/min AND patient is NOT adequately breathing, ventilate at a rate of 20 breaths/min using a bag valve mask and oxygen. Check for a pulse every one minute.
    - Heart rate > 60 beats/min AND patient is adequately breathing (both in rate and volume for age), administer oxygen via non-rebreather mask.

The other changes made to the "Key Points/Considerations" section were to emphasize the use of a "PEEP valve, if available, when performing assisted ventilations" and to "Evaluate for the evidence of ingestions (i.e., beta-blockers, calcium-channel blockers) and treat in accordance to respective protocols."

Marie Diglio conducted a roll call vote, and the results were 21 Approved, 0 Opposed, and 1 Abstention. The motion carried.

• Medical Standards brought forward a seconded motion to REMAC to accept revisions to the "Anaphylaxis/Severe Allergic Reaction (Adult and Pediatric)" protocol. One proposed change is the new definition of anaphylaxis that aligns with the national allergy societies. The protocol will define anaphylaxis as an allergic reaction with either respiratory compromise, signs of shock, or two or more signs/symptoms that affect the skin, mucosal, or gastrointestinal systems. Another definition is a history of anaphylaxis, known allergen exposure, and one of the mucosal or gastrointestinal signs/symptoms. Other changes include age-based dosing for Ipratropium Bromide and Albuterol, and if a Paramedic arrives first on the scene, they can administer the titrated dose if needed. These changes also affect the Asthma/COPD/Wheezing Protocol.

Marie Diglio conducted a roll call vote, and the results were 21 Approved, 0 Opposed, and 0 Abstentions. The motion carried.

Medical Standards brought forward a seconded motion to REMAC to accept revisions to the "Emergency
Childbirth" protocol. This motion changes the New York State Department of Health BLS protocols by moving an
EMT skill into the CFR scope of practice by moving the nuchal cord from the EMT section to the CFR section.

Marie Diglio conducted a roll call vote, and the results were 21 Approved, 0 Opposed, and 0 Abstentions. The motion carried.

• Medical Standards brought forward a seconded motion to REMAC to request an exemption from REMAC staffing standards specific to the B-HEARD calls for mental health. These are non-transporting vehicles.

The Behavioral Health Emergency Assistance Response Division (B-HEARD) of the FDNY is responsible for the Mental Health Response Units (MHRUs) that handle psychiatric emergencies. Each unit consists of two specially trained EMTs and a Mental Health Clinician (MHC) from Health + Hospitals. The BHEARD team is working towards an improved response model based on EMS requirements and feedback from past experiences. They have proposed changing the REMAC staffing standards for the interim B-HEARD Program. The proposal is to send one specialty trained EMT supervisor and one mental health clinician in a non-transporting vehicle to respond to non-violent psychiatric emergencies.

Marie Diglio conducted a roll call vote, and the results were 21 Approved, 0 Opposed, and 0 Abstentions. The motion carried.

The next Protocol Committee meeting is on November 3, 2023, at 10:00 a.m. via Zoom.

### QI Report (Michael Redlener, MD, Chair)

Joseph Raneri reported that the QI Committee met on October 4, 2023. The following is a summary:

- Representatives from the New York-Presbyterian Hospital EMS Stroke Unit presented an update about their program. The program, funded through philanthropic donations, is participating in multiple national and worldwide studies to demonstrate the efficacy of stroke units. One of the presentation's highlights was the units' ability to save an average of 30 minutes from the last known well to TPA administration. Once the committee receives authorization from NY-Presbyterian to share it, a copy of the presentation will be sent for REMAC's review.
- The course sponsor Staten Island EMT applied for approval to provide Paramedic refresher training in the region.

  The committee is reviewing the application.
- The committee has one pending regional restriction case and the necessary documentation. However, the Paramedic has not responded to the committee's attempts to schedule a meeting.
- The QI Committee is developing two QA projects on advanced airways and pain management. Regional data is being collected to populate the projects.
- The rollout of the FirstWatch Dashboard is currently in progress. Agencies that have updated their contacts should have received access to the dashboard and a unique key code to identify their agency. Although many agencies have responded, the committee is still waiting for updated data from some agencies.

### SEMAC/SEMSCO (Lewis Marshall, MD, JD

Jeffrey Rabrich, MD, reported that SEMAC/SEMSCO met on September 12, 2023, and September 13, 2023. The following is a summary:

- The Vital Signs 2023 Conference is in Syracuse this week (Oct 17-22). Register at www.vitalsignsconference.com or in person at the event.
- The Quality Metrics Committee has published its revised Quality Improvement Manual. It is available for review at www.health.ny.gov/professionals/ems/pdf/quality\_improvement\_for\_prehospital\_providers.pdf.
- The Finance Committee released the results of their salary survey. The NYS DOH received 3,831 survey responses, representing more than 10% of active NYS EMS responders. Highlights of the survey include:
  - o 37% of respondents plan to leave EMS in the next five years due to inadequate pay/benefits (65.7%) and better job opportunities outside EMS (51.3%).
  - o 45% of EMTs earn \$19/hr. or less, and 76% earn \$24/hr. or less.
  - o 35% of Paramedics earn \$29/hr. or less, and 61% earn \$34/hr. or less.
  - o 73% work more than 40 hours/week, 37% work > 50 hours/week, and 17.7% work 61 or more hours per week.
  - o 85% percent have experienced burnout or compassion fatigue.

- The Finance and Training & Education Committees surveyed the course sponsors to gather funding recommendations for the Bureau. As a result, EMS course funding has increased twice this year. Funding for EMT-Original courses increased by 38%, and funding for AEMT-Original courses increased by 80%. In addition, a new funding pilot program was introduced to reimburse EMT students who paid for their course and completed 12 months of service with an EMS agency. - The Legislative Committee recommends modernizing the EMS definition to include treatment in place, transport to alternate destinations, and making EMS an essential service.
- The Systems Committee released a Trauma Triage Guidelines resource that regions can customize to their systems. More information is available at https://saratogaems.org/?p=2024
- Certificate of Need (CON) actions for Scarsdale, Ossining, and Alden Village and Town were postponed until December.
- There is an ongoing discussion about regional credentialing of EMS providers. SEMAC/SEMSCO made a motion allowing REMSCOs to credential EMS providers, but the State Division of Legal Affairs (DLA) deemed it unlawful.
- The Public Health and Health Planning Council (PHHPC) has met multiple times to discuss emergency department boarding and ambulance wait times.
- Representatives of the New York State (NYS) Office of Mental Health (OMH) and Office of Addiction Services and Supports (OASAS) presented information about crisis stabilization centers. More information can be found at https://omh.ny.gov/omhweb/rfp/2022/scsc/.

#### **NEW BUSINESS**

#### **Vaccinations**

During the COVID-19 pandemic, REMAC developed a training program that allowed paramedics to administer vaccinations. This program was based on an executive order issued by the governor of New York, which authorized paramedics in the community paramedicine program to provide vaccinations for non-emergencies after receiving proper training. The New York State Department of Health also created a training program for this purpose and mandated

providers to participate. However, once the executive order was rescinded, Paramedics were no longer authorized to administer vaccinations. As a result, EMS agencies cannot offer vaccinations when they want to vaccinate their providers or conduct community outreach.

Nick Alexandrou, MD, motioned to allow all Paramedics to provide routine, regionally approved vaccinations exclusive of Executive Order or Community Paramedic Level Training. Glenn Asaeda, MD, seconded the motion.

Marie Diglio conducted a roll call vote, and the results were 21 Approved, 0 Opposed, and 1 Abstention. The motion carried.

A clarification during the meeting emphasized that the motion applies to Paramedics who received specific training to administer vaccinations.

#### Smart Glass Study

Mount Sinai and Pace University are conducting a Smart Glass Study and are recruiting EMS physicians to provide medical direction. This study is part of a larger research effort to design, develop, and evaluate smart glasses technologies to support EMS operations in the field. Physicians can report to two locations to volunteer approximately one hour for the study to observe and provide feedback on the outcomes in simulated patients from Paramedics receiving medical direction by traditional radio, phone contact, or Google Glasses. The glasses allow the physician to see the patient remotely. A link for signup will be provided after the meeting.
